## Medications in Middle School

#### 1. Overview

- a. ALL MEDICATIONS W/ FORMS MUST FIRST BE BROUGHT IN BY THE PARENT.
- b. All medications done in the morning (before school) should be given at home. Students do not have enough time to eat AND take medicine at school.
- c. ALL MEDICATIONS (except cough drops) require a medication form.
- d. All forms are online on the Cobb County Website (Policies/Rules, Section "J" Students). I also have forms in the Clinic, or I can email the forms

# 2. <u>Prescription Medications or Over-the-Counter medications that are to be kept in clinic and dispensed by nurse or authorized clinic staff.</u>

- a. Form Required: AUTHORIZATION TO GIVE (signed by the parent)
- b. These are kept locked in the Clinic and given at the correct time.
- c. Medications must match the prescribing information and will be given as ordered by the physician.
  - i. It can be given "as needed" or daily.
- d. They must remain in the original container (from the pharmacy). Prescriptions will require the original prescription on the container

### 3. Over-the-Counter Medications

- a. Form Required: AUTHORIZATION TO CARRY OVER-THE-COUNTER MEDICATION
- b. Middle School students carry the following Over-the-Counter (OTC) medications:
  - i. acetaminophen (Tylenol)
  - ii. ibuprofen (Motrin, Advil)
  - iii. Midol
  - iv. Aspirin
  - v. Antacids
  - vi. cough and throat lozenges
  - vii. OTC **ORAL** antihistamines (Benadryl, Claritin, Zyrtec)
- c. All other cough and cold medication (except lozenges), antihistamines, and (OTC) medication not listed above shall be kept in the Clinic

#### 4. Epi-Pens, Asthma Inhalers, & Diabetic Medications

- a. These are the <u>only</u> prescription medications students can carry with the *AUTHORIZATION TO CARRY EMERGENCY MEDS* form.
- b. Additional asthma medication, epinephrine auto-injectors, or diabetic medication should be kept in the Clinic if the first is lost or left at home.
- c. **<u>REQUIRES</u>** both parental & physician consent to ensure the student knows how to administer the medications properly.
- d. The original form will be filed in the Clinic, and the student must carry the copy **ALONG WITH IDENTIFYING INFORMATION** with the medication.
- e. Action Plans are nice to have w/ Epi-Pens & Inhalers but not required.

#### REMINDER:

- 1. <u>The parent is responsible</u> for bringing in the (1) signed original form along w/ the medication and checking in with the nurse.
- 2. Medication must be in its original container and <u>legibly labeled with the student's full name.</u>

3. If carrying: school nurse will keep the original on file and provide the student w/ a copy of this signed permission form on file – the student will have to carry the medication along w/ the copy of the form.
